Receipt of a Complete Zoning Bylaw Amendment Application and Public Meeting - File R-2024-083

- **Take Notice**, that the Council of the Municipality of Hastings Highlands has received a complete application concerning a proposed Zoning Bylaw Amendment according to Section 34(10) of the Planning Act.
- **Subject Property:** 0 South Baptiste Lake Road, being Part of Lot 15, Concession 4, being Part 1 on Plan 21R-26841, in the Geographic Township of Herschel, now Municipality of Hastings Highlands, as shown on the map attached.
- **Purpose and effect:** To change the zone category for the subject from Marginal Agricultural (MA) to a site-specific Special Rural Residential (RR-136) to recognize the lot area and to permit residential development within 500 metres of lands zoned Mineral Extractive (MX). This is a condition of severance for the County of Hastings Consent of Land Division File No. B117/23.
- Public Meeting: The Council of the Municipality of Hastings Highlands will hold a public meeting on Wednesday, December 4, 2024, at 9:00 a.m. at the Municipal Council Chambers, 33011 Highway 62, Maynooth, Ontario, to consider a proposed zoning bylaw amendment under Section 34 of the Planning Act.

Any person wishing to make written and/or oral submissions either in support of or opposition to the proposal are encouraged to attend the hearing. Options to attend and/or submit comments are as follows:

- B) Virtual Attendance (no comments) If you wish to view the public meeting in real time, but do not wish to speak to the application, the meeting will be live streamed and posted on the Municipality's <u>YouTube Channel</u>.

- d) In-Person Attendance 33011 Highway 62, P.O. Box 130, Maynooth, Ontario, K0L 2S0 Please note that members of the public are welcome to attend meetings in-person however seating in Council Chambers is limited.

Any person may attend the public meeting and/or make written or verbal representation either for or against the proposed amendment. Individuals who submit letters and other information to Council should be aware that any personal information contained within their communications may become part of the public record.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Hastings Highlands before the bylaw is passed, the person or public body is not entitled to appeal the decision of the Municipality of Hastings Highlands to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Hastings Highlands before the proposed zoning amendment bylaw is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

Please note that third parties (anyone who is not a specified person or public body as defined in the Planning Act) do not have the right to appeal a decision for a zoning by-law amendment to the Ontario Land Tribunal (OLT).

If you wish to be notified of the adoption of the proposed Zoning Bylaw Amendment, or of the refusal of a request to amend the Zoning Bylaw, you must make written request to address at the bottom of this page.

Additional information relating to the proposed amendment is available for inspection at the office of the undersigned.
