Take Notice That an application under the above file number will be heard by the Committee of Adjustment on **Thursday, November 14, 2024, at 8:30 A.M.**, at the Municipal Office Council Chambers, 33011 Highway 62, Maynooth under the authority of Section 45 of the *Planning Act*

Subject Property: 147 Peelow Rd, being Part Lot 22, Concession 9; Part 3, Registered Plan 21R18579; Part 4, Registered Plan 21R21064 in the Geographic Township of Monteagle as seen on the key map attached

Purpose of Application: To provide relief from

- a) Section 5.6.1 (ii) – No structure within 10 metres (32.8 ft.) of centreline of the road plus the front yard setback i.e. 10 metres (32.8 ft.)
- b) Section 5.9.2 (i) – No development within 30 metres (98.4 ft.) of the highwater mark of a waterbody or watercourse;
- c) Section 5.9.2 (ii) – No development or site alteration within a minimum distance of 30 metres from a steep and/or unstable slope;
- d) Section 5.25.5 – An accessory structure is to be a minimum of 3 metres (9.8 ft.) from a principal building;
- e) Section 10.3 (b) (v) – Minimum of 10 metres (32.8 ft.) from the front lot line;
- f) Section 10.3 (c) (i) – A natural vegetative buffer strip 30 metres (98.4 ft.) in width shall be maintained;
- g) Section 26.3 (iii) – Minimum of 30 metres (98.4 ft.) from high water mark of lake.

Effect Of Application: To allow a 29.72 square metre deck on the north side of the dwelling within 30 metres of the high water mark of Bartlett Lake and 10 metres of the front lot line.

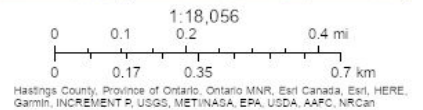

S. O. 1990, C. p. 13, S. 45 (10). Note: an application can only be appealed by the applicant, a public body or specified person (as defined by the *Planning Act*).
